PUBLIC HEARING, MONDAY, JUNE 12, 2017

A public hearing was held on Monday, June 12, 2017, in the Municipal Building, 555 Broadway Avenue, McKees Rocks, PA 15136. President Parrilla called the hearing to order at 6:30pm, and lead in Pledge of Allegiance and Moment of Silence.

Roll Call: Present for roll call was Commissioners McDermott, Richard, Papst, Zieger and Puskar. Secretary Incorvati and Solicitor Matta were present

Pittsburgh Curling Club; Andy Banfield and Steve Buffington were present. Solicitor Matta stated Planning Commission reviewed plan submitted at their meeting held May 25th and recommended the Board hold a public hearing to approve the conditional use application. Request would be permissible under conditional use application, commissioner would take under advisement and vote next meeting. Papst asked when project would start; Banfield stated count hearing is on 27th, hope to start building by October.

Structure was declared unfit for human occupancy. McDermott stated deplorable, gentlemen next door in securing to take it down, recommends taking ownership. Matta recommended building be declared a public nuisance and scheduled for demolition as funds become available.
