## Regular Monthly Meeting Minutes June 12, 2018

Parrilla states last year it was discussed to reduce board down to 7 members, addresses Solicitor to see if new map is completed. Map is not completed due to conflict amongst board regarding lines separating the wards. Matta to drop off map next week for board members to review and be ready to vote for next meeting in July.
