MINUTES OF THE REGULAR MONTHLY MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF STOWE, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, HELD ON TUESDAY, NOVEMBER 13, 2018, IN THE MUNICIPAL BUILDING, 555 BROADWAY AVENUE, MC KEES ROCKS, PA 15136.

The Regular Monthly Meeting of the Board of Commissioners of the Township of Stowe was held on Tuesday, November 13, 2018, in the Municipal Building, 555 Broadway Avenue, Mc Kees Rocks, PA 15136.

The meeting was called to order at 7:00 p.m. by President Papst, who led in the Pledge of Allegiance, then a Moment of Silence in honor of all Veterans and First Responders.

<u>ROLL CALL</u>: Present were Commissioners Putas, Parrilla, McDermott, Hoffman, Cropper-Hall, Faloshey, Derzic, Chestnutt and Papst. Also present were Solicitor Gary Matta, KLM Engineer Veronica Bennett, and Consulting Secretary Julienne Giuliani.

COMMENTS OF CITIZENS: No citizens were present to comment.

ENGINEERS REPORT: The Engineer reported on the Elizabeth Landslide Cleanup Project, the Fleming Avenue Stormwater Improvement Project, the ALCOSAN GROW 2019 Grant, the 2019 CDBG Year 45 Applications noting that the Island Avenue basketball courts was not approved for funding, the RoadBotics Update, and the Tunnel Way Project.
