COMMENTS FROM PUBLIC

Eugene Lovely (comment at voting meeting) – asked about the possibility of getting speed bumps on 10th Street between Woodward and Ridge. Commissioner Rugh stated that he will talk to Public Works and have them placed. Also, it was suggested that they be painted yellow since it is not a state requirement that a sign needs to be posted. Mr. Lovely appreciated the response and thanked the commissioners.

REPORTS

FINANCE - No report given.

PUBLIC WORKS – Presented by Commissioner Rugh. Stated that Public Works are trying to do "mini" speed humps. They are \$150 approximately and have currently been placed on Mancini's Way and on Stowe Ave. They will be placed around town.

POLICE – Presented by Chief M. Preininger. The \$50,000 grant money finally came through and the digital speed signs will be ordered.

There is a meeting on 9/12 with Chief Preininger, DC Wilker and Detective DiMichele at the high school to work on easing their tensions concerning this past week's stabbing after the football game.

If solicitors are seen in town, the officers are to take and run their identification as well as send them to the Township Building for a permit.

FIRE DEPARTMENT – Presented by Vice-President Chestnutt

ORDINANCE – Present by Vice-President Chestnutt. Interviews with three (3) ordinance officers were completed. The commissioners would like to consider Andrew Marsh. In the executive session a rate will be discussed.

ENGINEER – Presented by Engineer J. Marcink. Received the Penn/Derby grant reimbursement of \$125,000. Will be looking at Lower Highland for repairs/replacement with the possibility of using a GEDTF grant for this area. Also looking at other properties and streets for upcoming grant opportunities that will be, if not already open.
